

Terms and Condition

1. The base price for the auction is **Nu. 80,454.00** (Eighty Thousand Four Hundred Fifty-Four) only. Based on the base price, you should quote your price. The highest bidder will be awarded to execute the work. If there is tie in the highest bidder, the individual will be called to Dzongkhag Administration for further way forward.
2. The work shall include the following:
 - I. Demolition of two-unit single storey semi-permanent structure
 - II. Stacking and lifting of demolished materials.
 - III. Clearing the debris of the area complete.
3. The work shall be completed within 20 days from the issuance of the work order.
4. The committee from Dzongkhag administration, Dagana shall carry proper handing taking after the completion of the work.
5. Based on the bidders quoted amount, 70% of the amount shall be paid to the dzongkhag administration, Dagana at the start of the work and 30% shall be paid after completion of the work.
6. The Earnest amount of Nu. **15000(Fifteen thousand)** only shall be deposited to Dzongkhag Administration, Dagana in the form of Cash Warrant. The cash warrant shall be addressed to Dasho Dzongdag, Dagana. The earnest amount of the successful bidder will be retained until the auction is completed as security for subsequent bid to be offered by the bidder. On completion of the work, the earnest money of the highest bidder will be refunded prior to the deposit of the full quoted amount. The unsuccessful bidders can withdraw their earnest money after the award of work to the successful bidder.



