**Public Announcement**

The Dzongkhag Administration, Dagana would like to invite interested general public and business owners to apply for the plots to set up stalls and operate shops during three days Dagapela Annual Tsechu which will begin from 15/01/2023 till 17/01/2023. The detail terms and conditions for plot allotment and operation of shops are as detailed below:

1. The interested general public and business owners shall report on Thursday, 12/01/2023 at Dagapela Tashichoeling Geduen Lobdra at 10AM sharp for registration for plot allotment.
2. The plot allotment shall be carried out on a lucky draw basis on an aforementioned day (12/01/2023) by the Plot Allotment Committee.
3. Plot allotted for setting up non eatery/general stalls (eg. Clothes & toys, religious items, arts and crafts, farm tools & equipment, etc.) shall pay a fee of Nu. 3500/- for the entire duration.
4. Plot allotted for setting up restaurants and bars shall pay a fee of Nu. 5000/- for the entire duration.
5. Except for mobile businesses (selling doma, momo/singara & selrotis), all smaller shops/businesses which occupies space shall pay a fee of Nu.1000/- for the entire duration.
6. Security fee of Nu.500/- shall be collected from each plot/stall owners on the spot for waste management purpose. However, the collected fees shall be refunded on 18/01/2023 **only if** the individual stall area is properly being cleaned.
7. Plot fees shall be collected on the spot after lucky draw. Failing to pay the fees on the spot shall result in cancellation of the allotted plot and it will be allotted to another individual based on a lucky draw.
8. No gambling, games/sports and entertainment stalls shall be allowed to operate during the entire Tsechu program. The RBPs will strictly monitor the stalls and take necessary action, if found.
9. The stalls shall remain opened from 5AM till 11PM and the timing for stalls operation shall be strictly monitored by the RBP.
10. The stalls shall be properly dismantled and cleaned on 18/01/2023 by the concerned owners. Failing to dismantle by 18/01/2023 shall pay a fine of Nu.5000/- per day by the concerned owners.
11. Breaching of any of the aforementioned terms and conditions shall result in cancellation of the plot allotment.
